I agree not to begin property improvement(s) until the Architectural Committee notifies me in writing of their approval. If any change is made that has not been approved, the Committee has the right to ask me to remove the improvement from my property per the Governing Documents. I also agree that if I fail to maintain any alteration or change, my approval may be immediately revoked.
